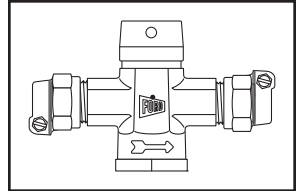
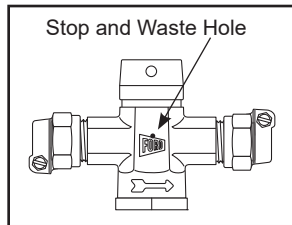


# SUBMITTAL INFORMATION

## Inverted Key Curb Stop with Stop and Waste - (Z44-xxxSW-NL style)



### PACK JOINT FOR COPPER OR PLASTIC TUBING (CTS) INLET AND OUTLET



Stop and Waste Hole

Sturdy stops allow 90° motion and are enclosed and protected.

Beveled EPDM rubber gasket provides hydraulic seal

Bronze pin securely locks the tee head to the inverted key

A NBR (Buna-N) rubber O-ring near the top of the inverted key offers extra protection against leaks.

Stainless steel screw activates clamp

A water passage on the inlet side provides upward pressure on the key, helping to hold it in the proper position.

Length

A bronze coil spring exerts a constant upward force on the bottom of the key. If the tee-head requires tapping to free a stuck key, the spring automatically re-seats the key in a watertight position.

Due to design variations related to sizing, items may differ from images above.

- Hole for attaching curb box rod is provided in tee-head
- Meets 100 PSI pressure requirement of AWWA Standard C800

**Optional full 360° tee-head rotation.** Add "R" to end of part number.
